SCHOOL AND BOARDING FEES FOR 2026

In terms of Section 38 (2) of the South African Schools Act No.84 of 1996, the Northwood School budget for 2026 was approved at the general meeting of parents held on the 28 October 2025 at the school.

The following resolutions were passed and approved by all parents present at the meeting:

1. The payment of school fees for 2026 is compulsory for parents in terms of Section 39, 40 and 41 of the South African Schools Act No.84 of 1996. Compulsory school fees are regarded as a statutory debt which is prescribed by law and may not be referred to a Debt Counsellor for debt review under Section 129 of the National Credit Act.
2. The criteria and procedures for the total, partial or conditional fee exemption for parents who are unable to pay school fees in terms of Section 39(b) of the South African School Act No.84 of 1996 was approved.

Fees for 2026:

Grade 8:	R77 370 less * R4 000	(Monthly payments = R6 670 per month x 11 months, Jan to Nov)
New learners:	R77 370 less * R4 000	(Monthly payments = R6 670 per month x 11 months, Jan to Nov)
Grade 9 to 12:	R73 370	(Monthly payments = R6 670 per month x 11 months, Jan to Nov)
Boarding fees:	R74 030	(Quarterly payments = R18 507.50 per quarter payable in advance or Monthly payments = R6 730 per month x 11 months, Jan to Nov)

Early settlement discounts for receipt of full fees by dates below (applicable only to school fees):

1. **First discount: 31st December 2025** **7½% = cash/eft deposit (R5 502.75)**
2. **Last discount: 28th February 2026** **4% = cash/eft deposit (R2 934.80)**
3. **Credit/Debit card payments will not qualify for a discount due to merchant rebates**
4. **Scholarships: No early settlement discount will be given to pupils who have been awarded a scholarship.**

Please note the following information:

1. * **The Grade 8** and new learners advance payment of R4 000, already paid in 2025, is deducted from the above amount of R77 370. Please note that this "non-refundable" payment is **NOT** subject to any discount structure. Discount is calculated after taking into account the "non-refundable" payment.
2. Debit orders, currently in place for 2025, will be carried forward by the finance department into 2026 and the amount of the debit order will be adjusted accordingly.
3. The school would prefer that upfront payments be made via EFT. Banking details: **First National Bank – Durban North (220426), Account number 507 9100 3665, Reference: Child's admin no/name & surname.**
4. Full payment of school fees to be received by 30 November 2026.
Method of payment of fees: Upfront payments or monthly payments & debit orders over 11 months
5. Activities not included in school fees: textbooks, stationery, uniforms, sport equipment, tours and functions, and cultural evenings.

We are looking forward to a great year in 2026 and would like to thank all parents in advance for your financial support in contributing towards Northwood achieving its Vision. We wish you and your family peace, rest and happiness over the Christmas season.
